

WATERFRONT PARADISE

Aqua at The Waterfront, Shell Cove includes the construction of 45 apartments which sits above a level of retail and public domain area, two levels of secured car parking, a Marina Services Building, parkland, an open public car park servicing The Waterfront Tavern, and civil works, forming part of the Boat Harbour Precinct which encircles the Shellharbour Marina.

Innovative builder Duffy Kennedy Constructions fulfilled the role of head contractor at the impressive Aqua at The Waterfront, Shell Cove, located in a fast growing area south of Wollongong on New South Wales' south coast.

A masterplanned community by Shellharbour City Council, with Frasers Property, Aqua is the first residential apartment building to be delivered fronting the newly created Shellharbour Marina. Duffy Kennedy also completed an early works package for The Waterfront Tavern and Dining Precinct.

The Aqua building at The Waterfront is integrated into the 270 berth boat harbour, marks a new era in the lifestyle of south coast residents and tourists. "Aqua has 3-levels of apartments in one, two and three bedroom configurations above the restaurant precinct at The Waterfront," said Duffy Kennedy CEO, Gavin Duffy. "They were an immediate success, with Frasers Property receiving over 1,000

expressions of interest and all apartments sold quickly when released, indicating the high level of demand for this type of project."

Duffy Kennedy began the design phase with the client in mid 2019 and site works commenced in the fourth quarter of that year. "Our talented team of design, construction and engineering experts were able to transform the client's architectural aspirations, including the multi-angled roof, into a workable and deliverable project," Gavin said.

A range of factors presented unforeseen challenges during construction, not the least of which was the impact of the COVID-19 pandemic. Establishing onsite safe working protocols, managing the impact of lockdowns on the sourcing of trades personnel and the additional time required for the procurement of materials, especially from China, added complexity to the building schedule. Higher than average rainfall in the later stages of 2020 delayed the painting

schedule and aspects of other external work, including kerb and guttering in the carpark.

Despite these setbacks, the Duffy Kennedy team successfully completed the project in the third quarter of 2021. "We pride ourselves on being intelligent builders, analysing each decision to ensure it is the right one for the project and our client," said Gavin. "We were able to proactively adapt to the environment created by the pandemic and kept the construction programme moving forward."

The Duffy Kennedy onsite team consisted of Project Manager, Mark Gladman and Site Manager, Ryan Fisher, supported by a contracts administrator, a cadet, two foremen, a leading hand and two labourers. At the peak of construction, up to 100 subcontractors were also onsite.
